11. These Terms and Conditions shall be governed exclusively by the laws of the State of Georgia. Any action at law or in equity by a member related to this PAIC membership, to challenge or enforce the Terms and Conditions of PAIC Membership or concerning any product or service acquired through his PAIC membership must be submitted exclusively to the jurisdiction of the courts of Cobb County, Georgia (USA). By the execution of this Membership Enrollment Form, each member consents to the personal jurisdiction and venue of these courts. In the event an action at law or in equity is initiated by a member and PAIC prevails, the member shall pay all costs incurred by PAIC in defending such action, including reasonable attorney's fees.
